## GENERAL COMPETITION | TERMS & CONDITIONS

**NO PURCHASE IS NECESSARY TO ENTER OR WIN.**

**A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.**

1. These terms and conditions apply to all competitions run by Imagine unless otherwise stated.
- 2. Eligibility:** All Competitions are open only to those who are 18 years of age or older as of the date of entry. The Campaign is only open to legal residents of Ireland, and is void where prohibited by law. Employees of Imagine its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable laws and regulations. Void where prohibited.

We will collect, store and process this data solely for the purpose of the Campaign and we will only keep it for as long as needed to complete and administer the Campaign as set out in our Privacy policy.

If you submit any third party personal data, it is your responsibility to obtain and maintain the consent of the data subject. It is a condition of entry that the winner(s) agree to their name, winning entry and county of residence being made publicly available and winners maybe required to participate in publicity, advertising and trade without further compensation, unless prohibited by law. If an image is submitted as entry to a Campaign, Imagine shall have the right to use the image submitted by you for promotional purposes, including on social media. Any data (including personal data) that you give to Imagine in relation to the Campaign may be shared with trusted third parties as set out

in our Privacy Policy. It is not permitted to enter any obscene, threatening, defamatory or illegal material; or any material which contravenes any rights, privacy or otherwise, of any person or group of persons to the Campaign. Any such material will result in immediate disqualification and will be reported to the relevant authorities.

**8. Imagine shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 3 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. **10. Terms & Conditions:** Imagine reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond Imagine's control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, Imagine] may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Imagine. Imagine reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. Imagine has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Campaign may be a violation of criminal and civil laws.
